Travelling in Winter

Scope

The review includes a summary of all of the RSA reports submitted to the RSA inbox during the period between July to September 2022 and then focuses in more detail on a sample of these reports. The objective of the review is to identify and highlight examples of good practice and any areas that need further development.

Summary information for all RSA reports submitted to National Highways inbox




Figure 1 - RSAs by scheme type submitted during this 3-month period (July - Sept 2022)

During this period **a total of 45 RSAs were submitted** to the inbox. This is 50% less than the 90 RSAs submitted during the previous quarter (April – June 2022). All of the RSAs submitted during this period were carried out to GG 119 Road safety audit. The types of schemes covered by the submitted RSAs are shown in Figure 1 below.




Figure 2 - RSAs submitted between 1 July 2022 and 30 September 2022 by National Highways operational area

Figure 2 below illustrates all RSAs submitted to the National Highways inbox between 1 July 2022 and 30 September 2022 by each National Highways operational area.

The sample

Of the 45 reports submitted, 30 sample reports were selected for review. The list below details the numbers of each stage of RSA forming the study sample together with totals submitted for the 3-month period.

RSA Stage	No. included in sample
Interim	3 of 3 submitted
Stage 1	13 of 19 submitted
Stage 2	5 of 7 submitted
Combined Stage 1 and 2	4 of 4 submitted
Stage 3	4 of 11 submitted
Stage 4	1 of 1 submitted

Based on the RSAs reviewed in the sample, the next section aims to identify good practice alongside aspects of the reports that could be changed to align with GG 119, or that could be improved so the RSA reports follow best practice.

Good practice

Previous RSA problems

There were several examples of where previous RSA problems were referenced and commented on. Clear reasoning was provided when the issues were being reiterated in the subsequent RSA.

An example of this was a section in an RSA report structured such that it included the problem and recommendation previously made, the agreed RSA Action and a comment from the Audit Team explaining why the problem had been reiterated in the current report.

GG 119 states that RSA problems and recommendations relating to incomplete RSA actions in the previous stage shall be reviewed and reiterated if the associated RSA actions are not complete.

Areas for development

Approval of the RSA Brief

Clause 5.13 bullet point 3 in GG 119 states that, "the RSA report shall include details of who supplied the RSA brief, who approved the RSA brief and who approved the RSA team."

In some cases, the RSA report stated that the National Highways Project Sponsor had approved the RSA brief, but an individual was not named. In other cases, no details of who approved the brief were included in the RSA report.

In total, 17 of the 30 sample reports (56%) were non-compliant with bullet 3 of clause 5.13 in GG 119.

Details of the site visit

Clause 5.13 in GG 119 further states that, "the RSA report shall include details of who was present at the site visit, the date and time period(s) when it was undertaken and what the site conditions were on the day of the visit (weather, traffic congestion, etc.)"

The review found that some RSAs in the sample were lacking details around invitations to the Maintaining Agent or who attended the site visit.

Some RSAs were still referring to the CHE letter dated 25th March 2021, which related to relaxations for site visits during the covid-19 pandemic, despite the RSA being undertaken in 2022, after the relaxations had ended.

In other cases, the arrival time on site was noted but not the period covering the overall visit.

Overall compliance with clause 5.13 in GG 119

Clause 5.13 lists items that need to be included in the RSA report. 23 of the RSA reports included in the sample (76%) had non-compliance that related to one or more of the 8 bullet points referenced in clause 5.13.
